Ambazonia-SCNC Merger

SCNC Chairman **Sam Elad** and **Simon Munzu** hold talks with **me** separately and each agreed that there must now be a merger. The SCNC has assumed responsibilities but has neither an elective, nor legislative, nor administrative, nor a judicial mandate for discharging it

After satisfying themselves on the high technicalities of the Order to Show cause both Sam Elad and Munzu confessed that we had a judicial authority through **HCB/28/92** which could clothe the home front in their operations. Accordingly it was decided that we sign a merger.

Ambazonian British Friendship Association immediately arranged a meeting at White House Hotel Regent Park London 25 June where we discussed it from 16:00 hours to 17:30 GMT

Unfortunately **Susungi, Fosung and Youngbang** said Ambazonia is one of the movements which should try to find a place under what they called the Umbrella organization the SCNC. So it was resolved to let the SCNC at home decide on the matter.

N/B. Ambassador Epie, Justice Mbu (who were still in America) **Mola Njoh Litumbe** (was indisposed) and the two Pa's, were not involved.

UNIFIED RESTORATION AGENDA

The Leadership of the Southern Cameroon National Council delegation whose composition appears on their London Communiqué of 22 June 1995, on the one part; And the exiled Ambazonian Head of State, who is presently in London, on the other part; having held discussions and agreed that the SCNC petition filed at the United Nations has, as stated in said London communiqué "signified the initiation of the process of the restoration of the Statehood of the Southern Cameroons", **do hereby acknowledge that the SCNC objective is now the same as that of Ambazonia and accordingly hereby AGREE that all action be hereafter placed under a unified leadership structure with internal and external facets.**

MUTUAL ADOPTION AND ADAPTATION OF STRATEGIES AND OPTIONS

All actions are hereby declared to be mutually adopted and adapted, where such derive legal authority from United Nations Charter article 51 and/or the Cameroun High Court order **HCB/28/92** both of which are binding on La Republique du Cameroun.

Wherefore we hereby make a worldwide appeal for assistance.
